Chaperone International has offered to fund the project.


We hold **no objection** to the proposed expansion since it doesn't affect the services that are currently earned from the current building.





Kanungu HCIV ART/Laboratory building is too small to accommodate a continuously growing number of equipment, staff and patients. We intend to make changes by adding clerking, counseling, duty rooms and add 01 toilet.

Chaperone International has offered to carry out the renovation/ extension. We request that you authorise the district civil engineer to carry out a pre assessment and make recommendations on the same.

Maternity pit latrine verandah developed a big horizontal crack that's progressive and is likely to cause another in the plinth wall if not worked on. The super structure will also be at risk of falling.


